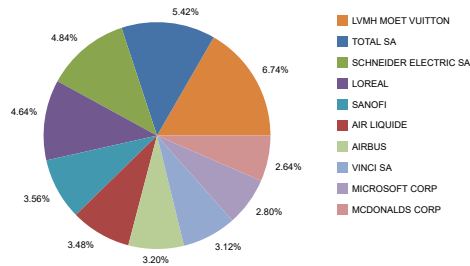

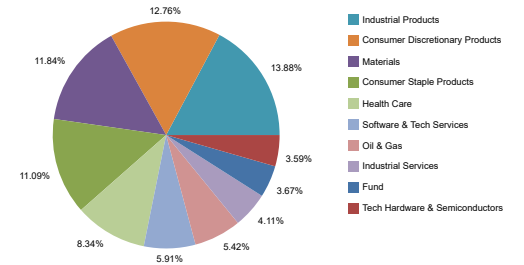

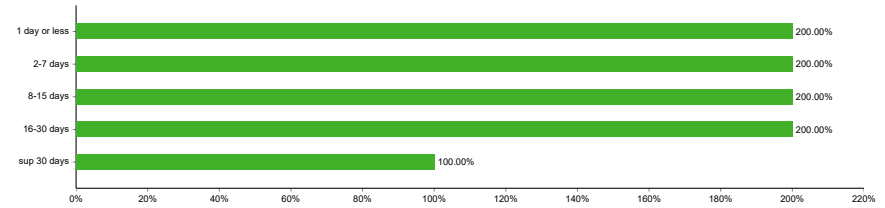


REDEMPTION COVERAGE RATIO - WATERFALL



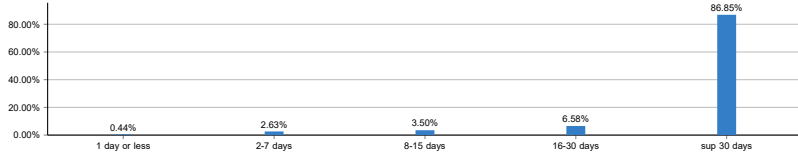

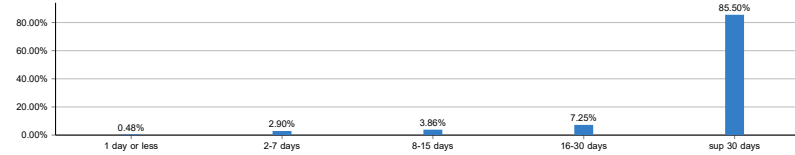

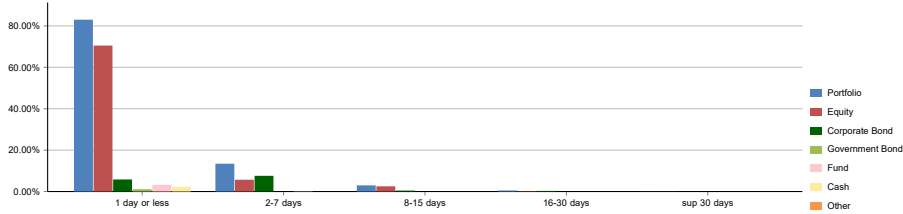

COVID 19 Scenario (28th of February 2020 - 25th March 2020)

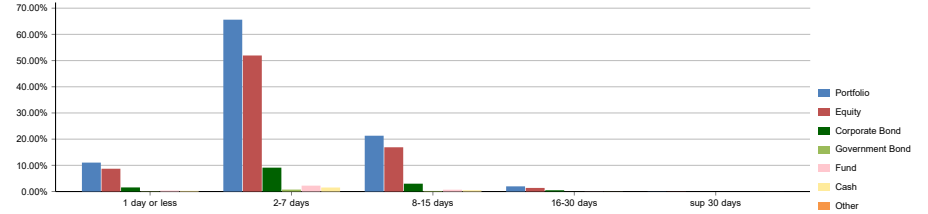

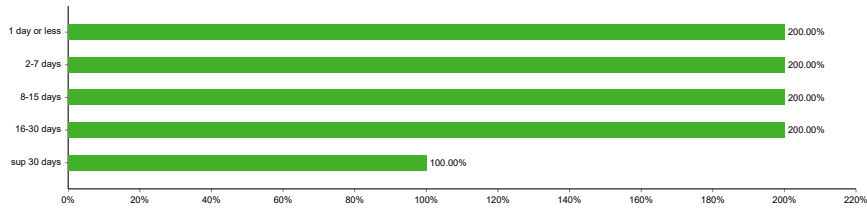

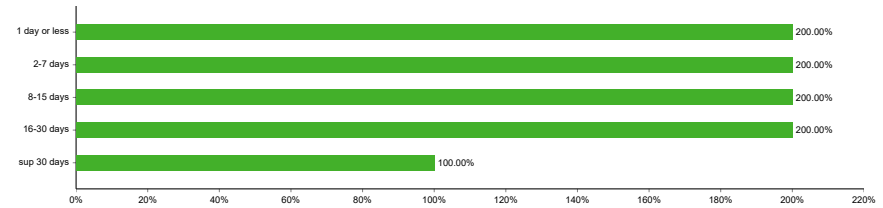


REDEMPTION COVERAGE RATIO - WATERFALL



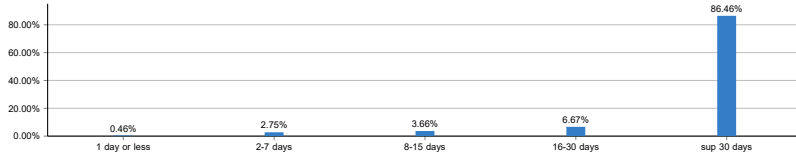

REDEMPTION COVERAGE RATIO - SLICING



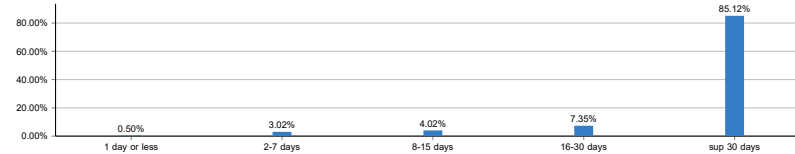

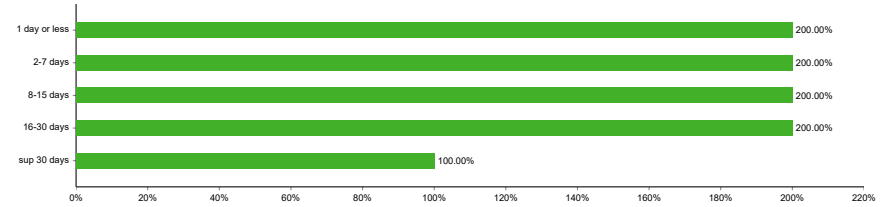


REDEMPTION COVERAGE RATIO - WATERFALL



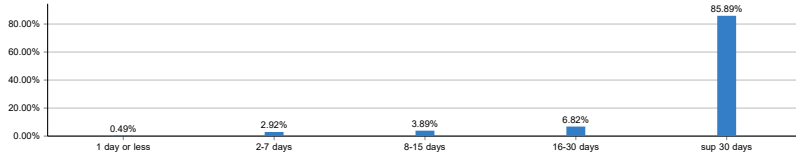

REDEMPTION COVERAGE RATIO - SLICING



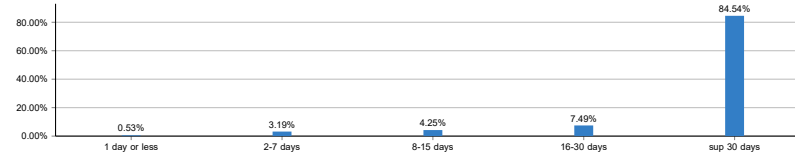

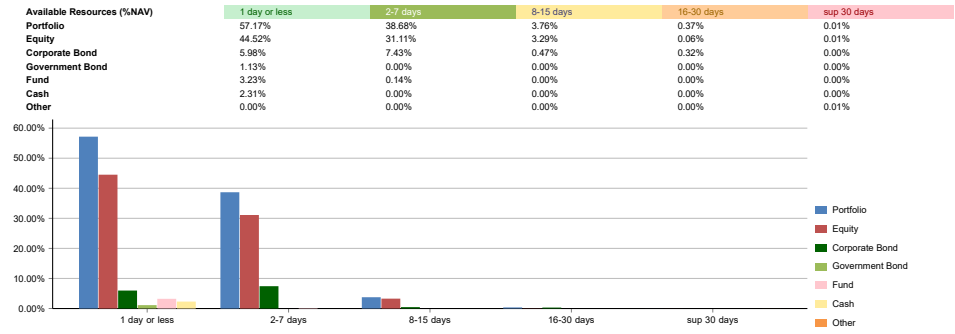

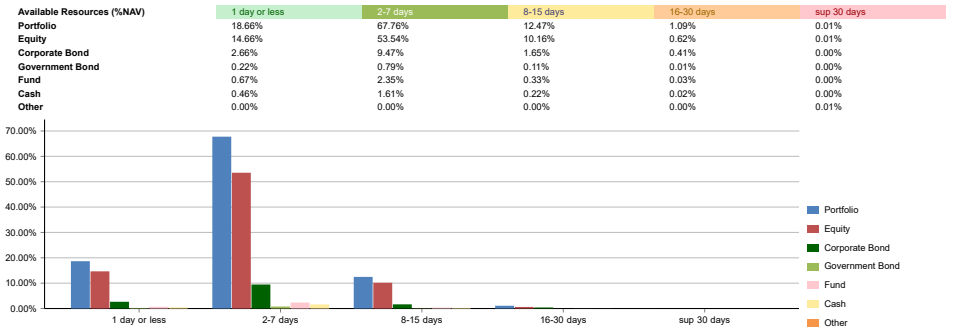

Index Decrease 30% Scenario

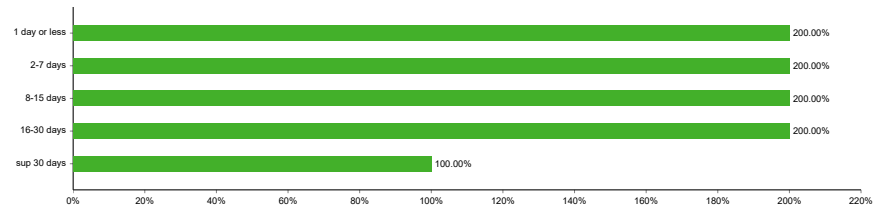

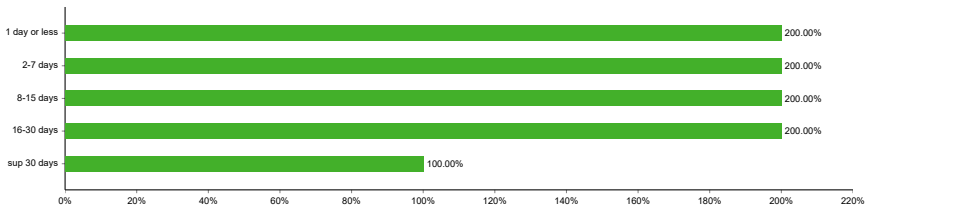


REDEMPTION COVERAGE RATIO - WATERFALL

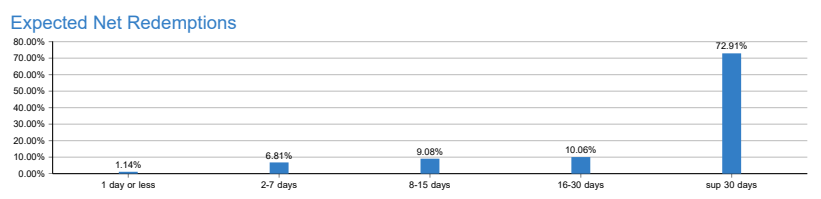

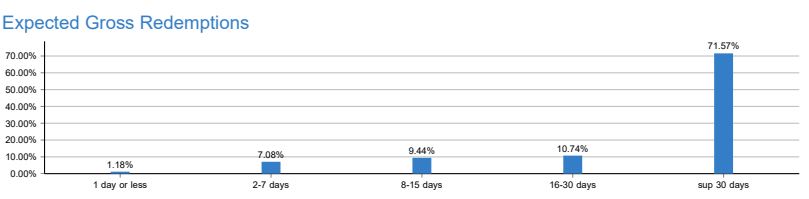
REDEMPTION COVERAGE RATIO - SLICING



LIABILITY LIQUIDITY PROFILE - NET

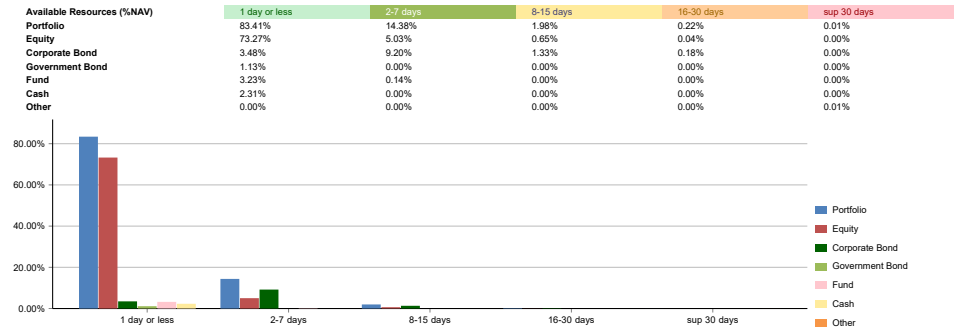


LIABILITY LIQUIDITY PROFILE - GROSS

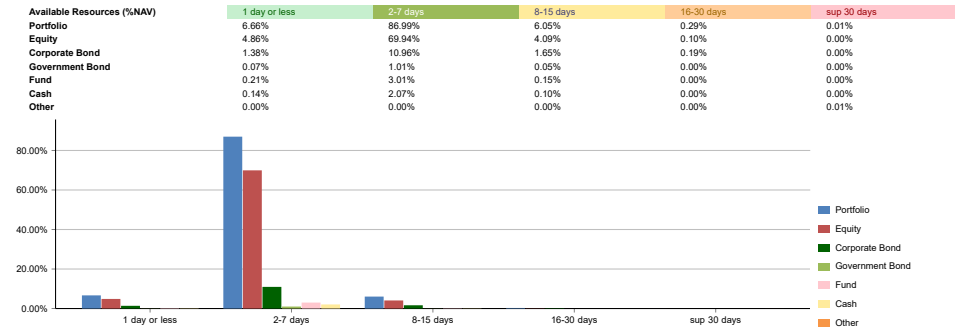


Interest Rate Increase 30 % Scenario

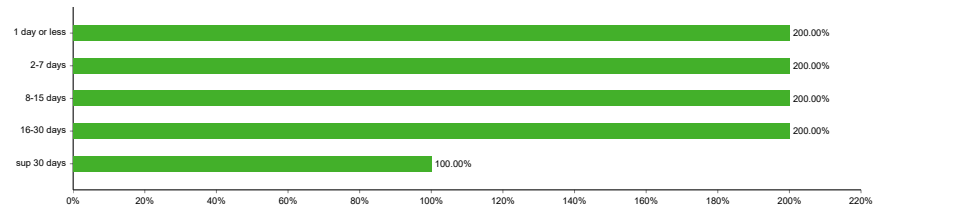

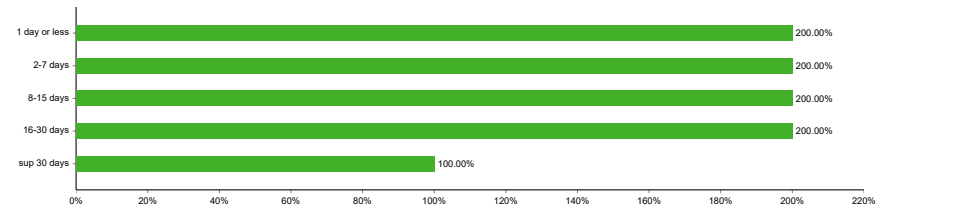


REDEMPTION COVERAGE RATIO - WATERFALL

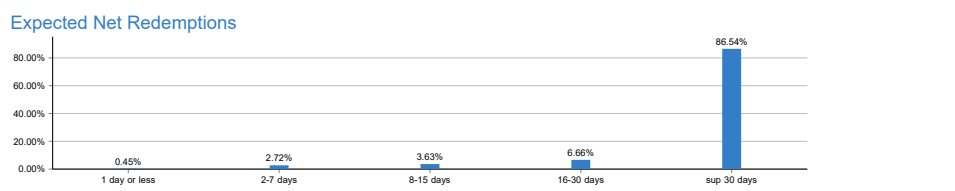

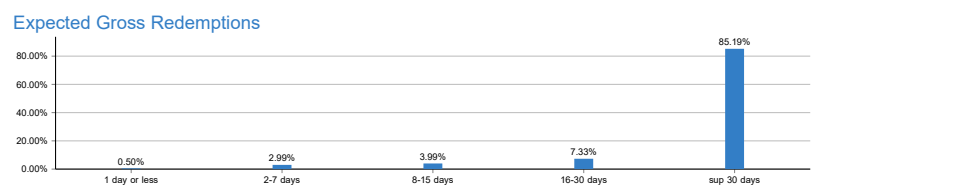
REDEMPTION COVERAGE RATIO - SLICING

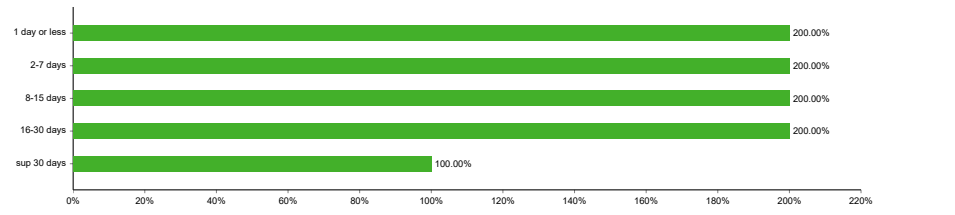

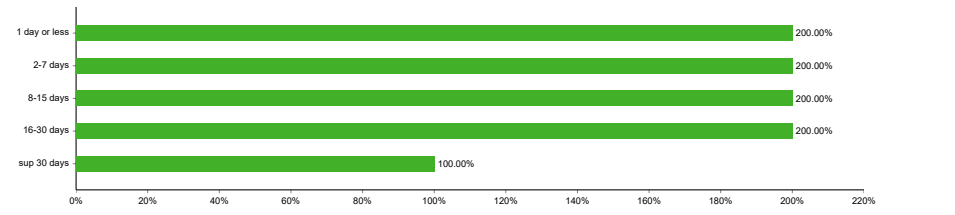


REDEMPTION COVERAGE RATIO - WATERFALL

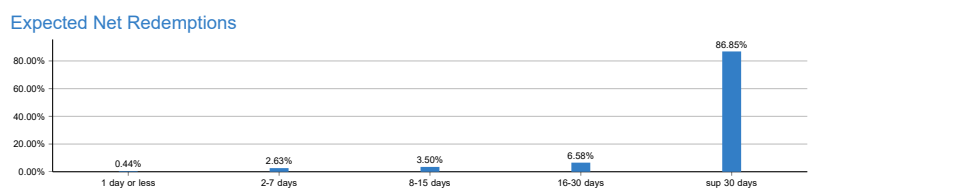

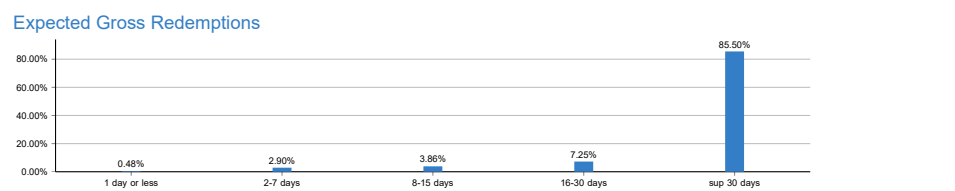
REDEMPTION COVERAGE RATIO - SLICING

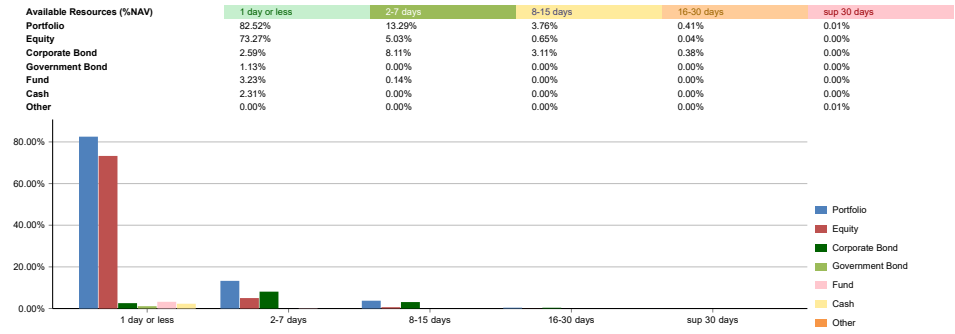


LIABILITY LIQUIDITY PROFILE - GROSS

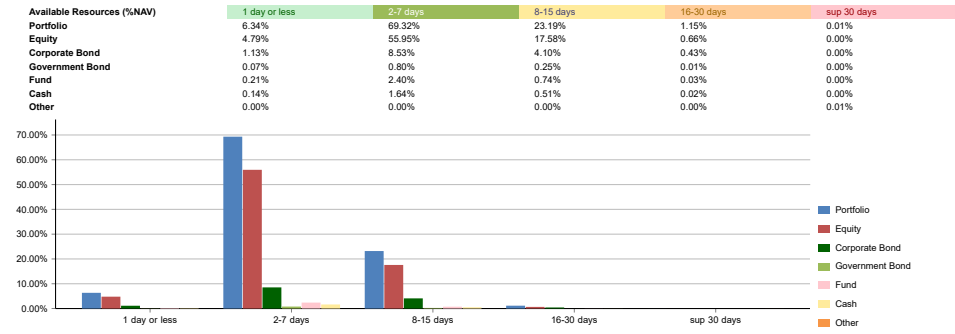


Credit Crisis Scenario (Increase 100% CDS spread)

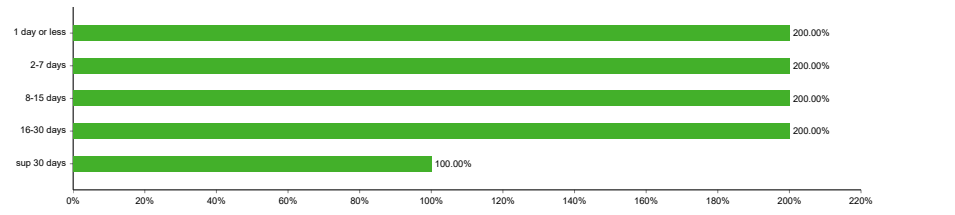

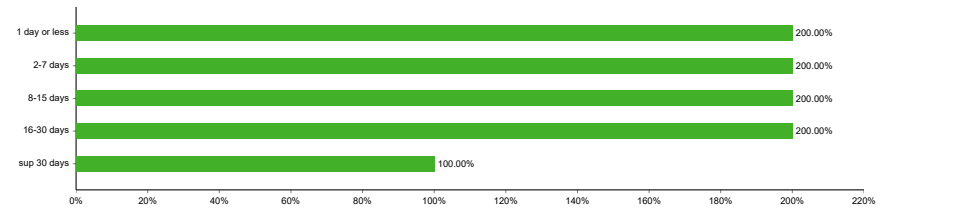


REDEMPTION COVERAGE RATIO - WATERFALL

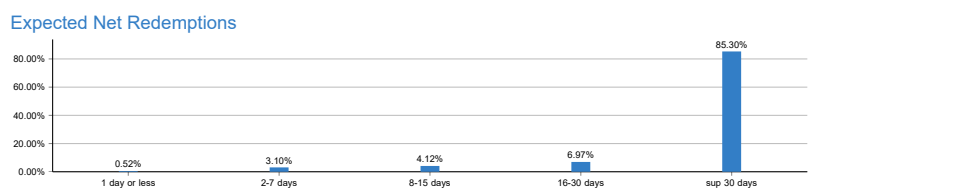

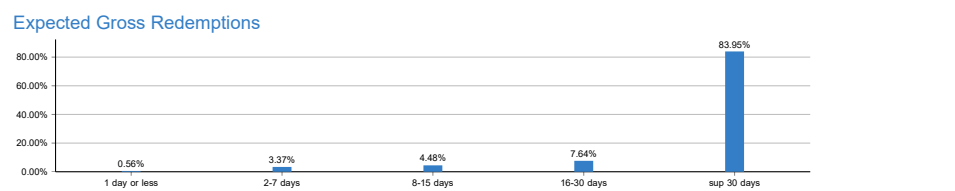
REDEMPTION COVERAGE RATIO - SLICING

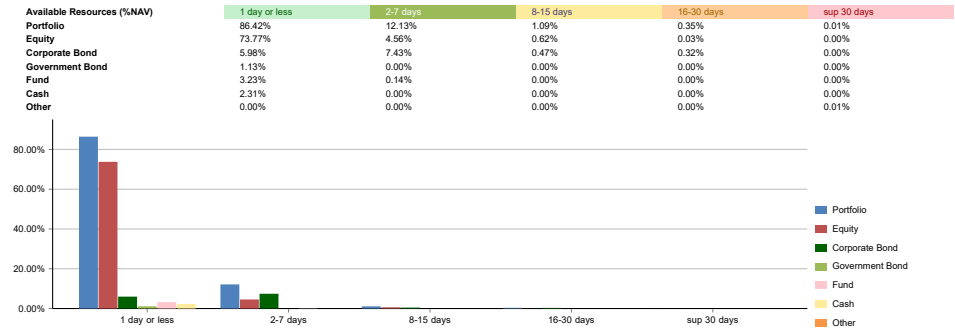

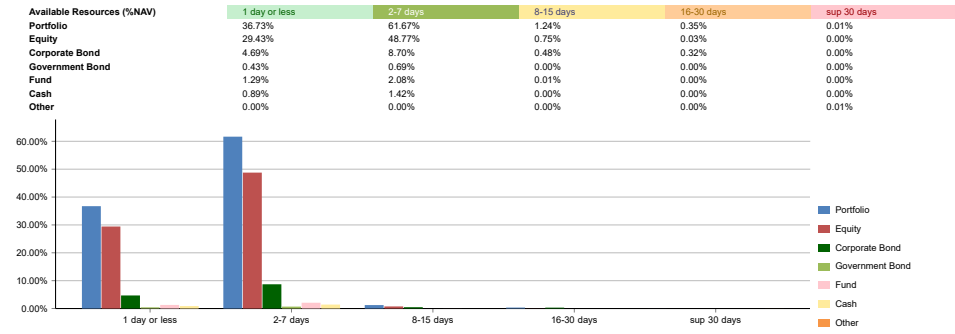

Top 3 Investors Redeeming Scenario

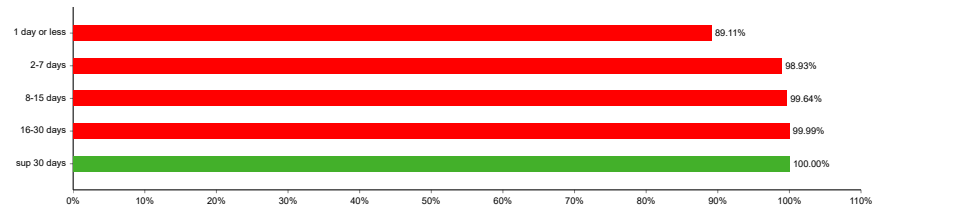

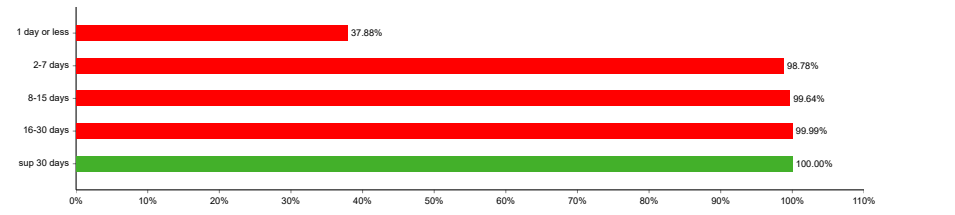
PORTFOLIO LIQUIDITY PROFILE - ASSET SIDE - SLICING

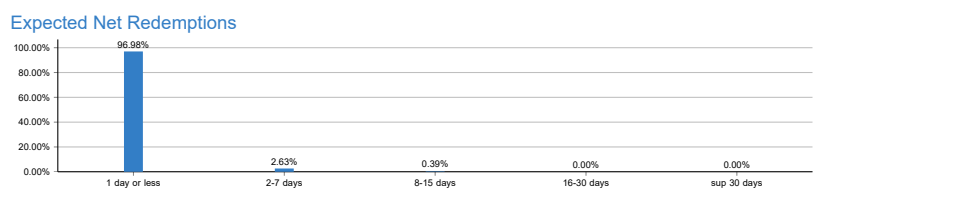

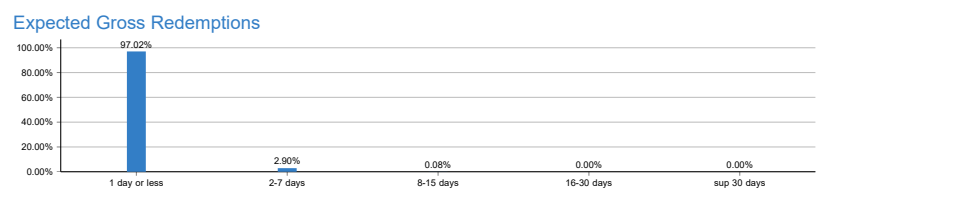

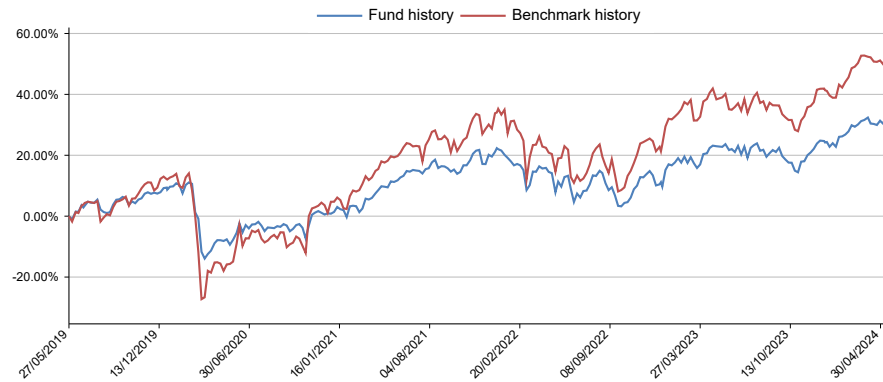

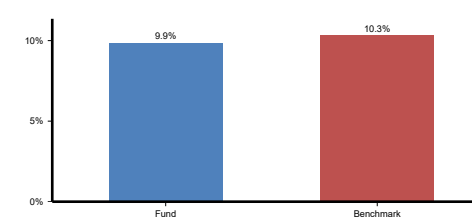

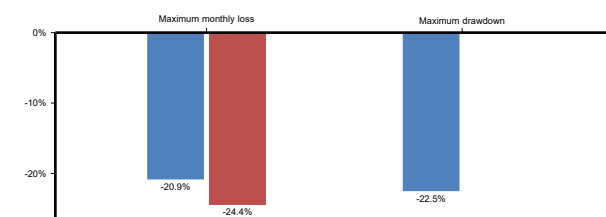
